This is a commercial product whose exact ratio of components may vary slightly. Minor quantities of other non hazardous ingredients are also possible.

The SWA TWA exposure value is the average airborne concentration of a particular substance when calculated over a normal 8 hour working day for a 5 day working week. The STEL (Short Term Exposure Limit) is an exposure value that may be equalled (but should not be exceeded) for no longer than 15 minutes and should not be repeated more than 4 times per day. The term "peak "is used when the TWA limit, because of the rapid action of the substance, should never be exceeded, even briefly.

Section 4 - First Aid Measures

General Information

Self Injection: Accidental self injection may lead to an inflammatory response. Medical advice

should be sought on the management of deep injections, particularly those near a joint or associated with bruising. If possible the application of gentle squeezing pressure with absorbent material (e.g. facial tissues) at the injection site will swab up unabsorbed vaccine. Strong squeezing of the site should be avoided. The damaged area should be thoroughly cleansed and a topical antiseptic applied.

Check your tetanus immunisation status.

Inhalation: First aid is not generally required. If in doubt, contact a Poisons Information Centre

Skin Contact: Irritation is unlikely. However, if irritation does occur, flush with lukewarm, gently

Section 5 - Fire Fighting Measures

Fire and Explosion Hazards:

There is no risk of an explosion from this product under normal circumstances if it

is involved in a fire.

Section 6 - Accidental Release Measures

Accidental release: This product is sold in small packages, and the accidental release from one of these

Section 10 - Stability and Reactivity

Reactivity: This product is unlikely to react or decompose under normal storage conditions.

Fire Decomposition: Only small quantities of decomposition products are expected from this products at

Oxides of sulfur (sulfur dioxide is a respiratory hazard) and other sulfur compounds. Most will have a foul odour. Water, sodium compounds. Carbon monoxide poisoning produces headache, weakness, nausea, dizziness, confusion, dimness of vision, disturbance of judgment, and unconsciousness followed by

Local Effects

Target Organs: There is no data to hand indicating any particular target organs.

Persons who have taken pentosan orally report a variety of side effects, primarily gastrointestinal complaints such as diarrhoea, heartburn, stomach

pain. Hair loss, headache, rash, insomnia have also been reported.
